Wiring diagram

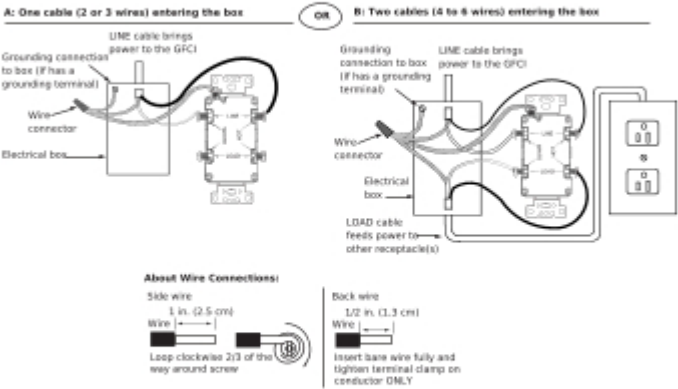
