Wiring diagram

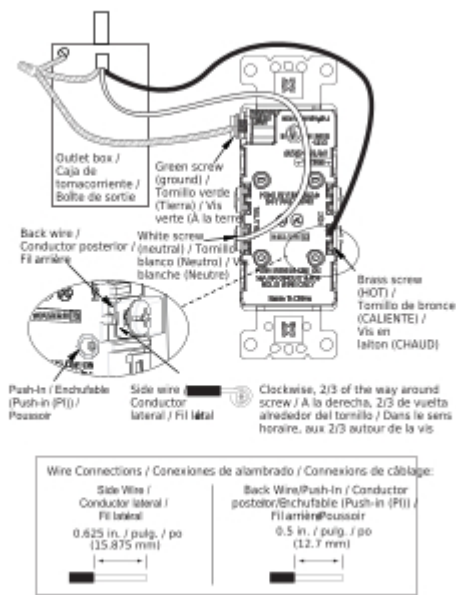
